IT/HIE Incentives from Blue Cross: NPO is currently part of three IT/HIE initiatives through BCBS PGIP program - ADT (admissions, discharge, and transfer), Med Rec, and DirectTrust. These initiatives are largely targeting primary care practices with the exception of the DirectTrust initiative, which is targeting all providers. Funds for these initiatives will be paid in January 2018's PGIP payment to NPO from Blue Cross. Funds for these initiatives will be used to compensate practices for their active participation.
